25-YEAR / 10-YEAR LIMITED WARRANTY

(For Metal Roofs and Shingle Roofs)

LIMITED WARRANTY

Razorback Roofing Products warrants to you, the original owner of the RAZORSTICK HT, that the RAZORSTICK HT will not contain a manufacturing defect that causes leaks for the following periods:

- 25-Year Protection for Metal Roofs – Razorstick HT is engineered to withstand the extreme heat and movement common with metal roofing systems, delivering decades of dependable performance.
- 10-Year Protection for Shingle Roofs – Provides long-lasting durability and weather resistance when installed under asphalt shingles, safeguarding homes from leaks and water intrusion.
- Confidence Built-In – Backed by Razorback Roofing Products, this warranty ensures your roof is protected with proven reliability you can trust.

WHO IS COVERED BY THIS LIMITED WARRANTY; TRANSFERABILITY

You are covered if you live in the United States or Canada and are the original property owner (not a builder or installer) or the first subsequent owner if the warranty is properly transferred.

This Limited Warranty may be transferred only once. The second owner must notify Razorback Roofing Products in writing within 60 days after the property transfer for warranty coverage to be transferred.

After a proper transfer:

- Metal Roofs – Warranty reduces from 25 years to 10 years from the transfer date (or until the original warranty expires, whichever comes first).
- Shingle Roofs – Warranty reduces from 10 years to 2 years from the transfer date (or until the original warranty expires, whichever comes first)

EXCLUSIVE REMEDY

Razorback Roofing Products' sole responsibility for breach of this Limited Warranty is to provide you with replacement RAZORSTICK HT only. This warranty does not cover the cost of labor, disposal, or any other costs or materials related to the installation, repair, or replacement of RAZORSTICK HT or any overlying roofing materials.

NOTIFICATION OF CLAIM

You must notify Razorback Roofing Products within 30 days after noticing a problem and provide proof of installation date and ownership.

EXCLUSIONS FROM COVERAGE

This Limited Warranty does NOT cover conditions other than leaks. This Limited Warranty also does NOT cover leaks caused by any of the following:

1. Damage resulting from anything other than an inherent manufacturing defect, such as:

- (a) Improper fastening, faulty application, or application not in strict accordance with Razorback Roofing Products printed instructions.
- (b) Subsequent structural changes or alterations to your roof, such as installation of equipment on your roof (solar panels, A/C units, etc.).
- (c) Settlement, movement, or defects in the building, foundation, roof deck, or materials used as a roof base.
- (d) Damage from incompatibility with any non-Razorback product.

2. Acts of nature, including but not limited to:

- Any hurricane above Category 2
- Tornadoes
- Hail, fire, lightning, earthquakes, or other extreme weather events

3. Improper storage or handling of the RAZORSTICK HT.

SOLE AND EXCLUSIVE WARRANTY

This Limited Warranty is exclusive and replaces all other warranties, express or implied, including merchantability or fitness for a particular purpose. Razorback Roofing Products will not be liable for consequential or incidental damages.

EFFECTIVE DATE

This Limited Warranty is effective for RAZORSTICK HT installed after January 1, 2025
